Stephanie Smith moved to Clark County in 1987 and has been a resident of North Las Vegas since 1991. She was elected to the City Council in 1997.

Ms. Smith was elected to the Nevada Assembly in 1992 and served one term in the legislature. She also served as a member of the governor's Maternal and Child Health Board.

Some of the many boards she serves on include the Clark County Health District, Chairman of the North Las Vegas Library District Board of Trustees, North Las Vegas Housing Authority, Nevada League of Cities Legislative Committee, and Southern Nevada Regional Planning Coalition. She serves on the board of the Nevada Arts Advocates and on the advisory board to local public radio station KNPR. Additionally, Ms. Smith serves on the Clark County Environmental Advisory Committee and is Chairwoman of the Clark County Animal Advisory Committee, a member of the Clark County School Bond Oversight Committee, and a member of the Debt Management Commission.

A graduate of Brigham Young University, Ms. Smith received a Bachelor of Arts degree in 1983 in music. She is married to Jeffery Englehart, a former captain in the United States Air Force and now a plant superintendent at a local construction company.
