The City of North Las Vegas (City) is requesting bid proposals for the above Project:

SCOPE OF WORK: Work shall include the demolition of existing earth berms at the site and the construction of two new ranges and all incidental work shown in the Bid Documents. The Project shall be completed within **one hundred eighty (180) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization. The estimated monetary range of the project is **\$800,000 to \$900,000**.

All bids must be hand delivered or sent by mail service and be received in the office of the City Clerk, 2250 Las Vegas Blvd. North, Suite 800 (8th Floor), North Las Vegas, NV 89030, prior to **close of business on Wednesday, October 9, 2024**. Bids received after the designated time will not be considered and will be returned to the Bidder unopened. **Bids will be opened at 9:00 a.m. on Thursday, October 10, 2024 by the City Clerk and witnessed by Public Works personnel.
