The City of North Las Vegas (City) is requesting bid proposals for the above Project.

**SCOPE OF WORK:** Work includes trenching, installing approximately 853 feet of 4" conduit, transformer pad, bollards to deflect errant vehicles, pull box, and associated appurtenances for NV Energy use as part of the meter system. The Work does not include any installation of electrical components, connection, and energizing the system but is limited to underground conduit, concrete pad, and other civil related type of improvements. The Work is located in the Apex region within the City of North Las Vegas; in particular, approximately one (1) mile southwest of the intersection of US 93 (Great Basin Highway) and Grand Valley Parkway. The Project shall be completed within **ninety (90) consecutive calendar days** from the date specified in the Notice to Proceed, which time shall include resolution of all punch list items, final cleanup and demobilization.

**The cost estimate range is \$181,000 to \$221,000.**

**A PREBID CONFERENCE** will NOT be held for this project. Bidders are expected to familiarize themselves with the project site and conditions without the attendance of City representatives. The deadline date for submittal of questions or concerns is no later than November 6, 2024.

**BID OPENING:** All Bids must be submitted in a sealed envelope, plainly marked, as detailed in Paragraph E, of the Instructions to Bidders, Section IB.1. All bids must be hand delivered or sent via mail service and be received in the office of the City Clerk, 2250 Las Vegas Blvd. North, Suite 800 (8<sup>th</sup> Floor), North Las Vegas, NV 89030, prior to **close of business on Tuesday, November 19, 2024**. Bids received after the designated time will not be considered and will be returned to the Bidder unopened. **Bids will be opened at 10 a.m. on Wednesday, November 20, 2024** by the City Clerk and can only be viewed by bidders via live stream by logging into <https://meet.google.com/tmb-krib-cwd> or dialing (US) +1 513-823-3083 PIN: 622 386 434#. Apparent bid results will be sent via the email address provided by the prospective bidders on their signature page of the Bid Proposal. The 1% Contractors List included in the Bid Proposal may be provided at submittal within the bid proposal, or if not will need to be provided within 2-hours of the City's email notification of the three (3) apparent low bidders.
